And best of member the part of the 1970s original where the all, it's right here in Illinois! lead character "Ben Freeling" screams at his boss about moving the headstones but leaving the bodies behind that resulted in the manifestation that terrorizes his family throughout the film. Other famous stories share a similar scenario, most notably the "Black Hope Haunting" (see next issue).

Most people just can't believe that someone would leave bodies behind and just build over the sacred, hallowed ground. But, in all of my years of research, this actually happens quite a bit more often than most people think. Channing Elementary School is one of those places, where the expansion of cities and concerns for space outweighed the costs of ensuring that all of the bodies had indeed

CHANNING STREET CEMETERY

Records indicated that the original cemetery was established sometime in the 1830s on the southwest corner where Division and Chapel Streets meet. Additional land was donated to the cemetery by a Mr. James T. Gifford, and eventually became known as "Channing Street Cemetery". It was opened for public burial in 1845.

Most of Elgin's early settlers were laid to rest in Channing Cemetery. In fact, according to the Elgin Historical Museum's website, prior to 1889, it was the only cemetery in Elgin.

... the continuing increase in Elgin's population, tery, and plans for the park began to proceed. and the need for additional "living space" within the city limits, and the over-crowding of the cemetery itself, the City of Elgin decided to establish a new, larger cemetery on the outskirts of town. In 1888, The City of Elgin established "Bluff City Cemetery", which consists of over a hundred acres of land dedicated to the cemetery.

In 1889, the City of Elgin then requested that the families with loved ones buried in Channing Street Cemetery pay to move the bodies and markers from Channing to the new Bluff City Cemetery, as the city had plans to convert the old cemetery into a park.

However, burials continued to take place in Channing Cemetery all the way until at least 1906, when the last recorded burial occurred. At that time, it is estimated that there were over 3,500 graves interred at Channing Street Cemetery.

By 1910, however, the city had let Channing Cemetery fall to near ruin. Many of the headstones were broken, missing, or had been reclaimed by the earth, gone and lost forever. The city still wanted to convert the land to a park, but continually ran into legal obstacles as they tried to acquisition the land.

In 1915, they slowly began to re-landscape the property, even though they hadn't completely and legally wholly acquired the property, and ignoring the fact that not all of the graves had been moved to Bluff City.

In the 1920s, the city moved a veterans memorial from Channing Cemetery to Bluff City, and continued to make plans for the park, even though they still hadn't completely acquired the land.

Finally, in 1945, Channing Street Cemetery officially closed. By 1947, it was thought that all of the remains had been removed from the property and relocated to Bluff City or another nearby ceme-

DEATH TO THE CEMETERY

In 1949, the City of Elgin began to clear four acres of land in the southwest section of the land in anticipation of construction on the long-awaited park. Rumors allege that unmoved bodies were contracted to the removed from the premises by bulldozer, and some Elgin residents who were children living in the area at the time recall seeing bulldozers actually breaking up old coffins and scattering the remains on the grounds.

This blatant disrespect for the remains is what some believe cause the haunting activity reported at the park and school which sit on the property today.

In 1968, Channing Memorial Elementary School was built on the northwest corner of the former cemetery, at the intersection of Fulton and Channing Streets. That same year, the Elgin Area Historical Society (EAHS) dedicated a memorial marking the cemetery site.

THEY FOUND THE BODIES

In 1998, the School District of Elgin approved an expansion to Channing Memorial Elementary school. However, due to the limited space available to the school, they knew they would have to expand into the cemetery, and would most likely find graves that were left behind and long forgotten.

In anticipation of this event, the district called in a team of archaeologists, lead by Douglas Kullen, to respectfully dig and remove any graves that might be found in that specific area needed for the expansion before construction would begin.

During a preliminary dig in the fall of 1998, the team confirmed that at least eight grave sites existed in the area needed for the expansion, and work was set out to begin the ... CONTINUED

work came to a halt.

When work resumed in early spring of 1999, diggers unearthed the remains of two complete skeletons, one belonging to an unidentifiable adult, and the other belonging to a small child. Although diaper pin were found with the remains.

By the time the dig was complete, thirteen grave sites in total were discovered, and remains the were shipped off to attempt identification. However, original because the Channing Cemetery burial records have long been lost, there is little hope of actually being

able to identify any of the remains.

Eventually, the expansion to the school was completed and opened.

THE SPIRITS ARE RESTLESS

Over the years, students and utility workers have found pieces of coffin hardware, such as nails and handles, tombstone fragments, and even occasionally bones and bone fragments while on the Ground". school grounds.

Many students also report many various forms of ghostly activity, ranging from strange taps, raps, footsteps and voices to seeing shadows and full-bodied apparitions. Some residents get "the heebie-jeebies" from the park on the opposite corner of the property, and will not enter at night.

A strange orb-like light phenomenon has also been reported to be seen on the grounds at

... excavation process, but winter set in quickly, and night. Rumors also allege that when construction of the park occurred, any bodies and graves they found were dumped into a "mass grave" on the far south end of what is now the park, although no official records indicate that this is fact.

However, many residents report strange, unthe wood that made up the coffins had completely easy feelings when walking near the land where the decomposed, the metal nails, handles and even a mass grave may exist. To this day, the only remaining marked grave on the property exists on the far

> southwest corner and belongs to William Hackman, a former employee of the Elgin National Watch Company.

> To this day, no one really knows just how many graves were left behind. There could still possibly be the scattered remains of hundreds of people lying beneath the grounds of

Channing Park and around Channing Elementary School. Children playing in the playground or in the park are literally playing on top of a forgotten graveyard.

The memorial marker placed by the Elgin Area Historical Society is their only acknowledgement, and reads: "Their wordly tasks completed, Elgin's Pioneers were laid to rest in this Hallowed

PARANORMAL 101:

The Roswell Incident & Area 51

The words "Area 51" are well-known in today's Pop Culture, instantly bringing to mind UFO crashes and government conspiracies. Conflicting reports and unclassified documents that have been revealed over the years and made public knowledge have cast doubt on the official story of the incident.

What really happened that night in Roswell, New Mexico? We may never know for sure, but we can look at what we do know...

THE CRASH IS REPORTED

In July of 1947, Bill Brazel, a worker on a local farmstead, noticed a

debris field while out working just north of Roswell, New Mexico. He reported the incident to the local authorities, and the military became involved. They immediately took possession of the crash site, and wouldn't allow press in to take photos.

It wasn't long before one of the military officials told a press agent that they had captured what was believed to be the remains of a flying saucer and it's occupants (presumed dead). The story was reported in the Roswell Daily Record, as shown above (Image Source: alien-ufo-research.org).

This started a frenzy as people were wondering whether we were alone in the galaxy or not, or if aliens were indeed visiting our planet. Multiple reports were printed by the Roswell Daily Record as the case seemingly unfolded before our eyes. The army had captured a crashed flying disc at a ranch in Roswell, New Mexico. The news was astounding.

THE STORY CHANGES

However, within a few days, a new story came out. The crashed disc wasn't really a UFO or a disc at all... it was reported to be the crashed remains of a Project Mogul weather balloon.

This story became the "only true" explanation given for the events at Roswell, and one that the government and armed forces continue to tell the public to this day. But, some sources believe differently.

EVIDENCE TO THE CONTRARY

There are a few famous photos from the Roswell crash, most notably the snippet from the Roswell Daily Record we have featured above, and the photo of Lt. Walter Haut holding pieces of debris from the crash site for photographers. Although initially reported as... CONTINUED

outside of the armed forces. Lt. Haut is the one known as "Area 51".) who informed the press agents that there had indeed been a crash of a UFO at Roswell.

When the military changed the story, however, he didn't "make a big deal of it", as any good soldier wouldn't. He went on with their version of events up until the day he died in 2005. At that time, there was an affidavit that was to be opened after his death. It was a big slap back at the government, and basically an "I told you so" confession.

OTHER PROOF

You don't have to be a genius to do some extensive Google searching and find all kinds of documents and released "confessions" of witnesses, including other now-retired or dead military officials, secretaries, soldiers, doctors and more, all claiming to have been involved with or witness some of the events. All confirm that a ship did indeed crash at Roswell, and that in fact three EBEs

There is a great deal of signed statements, video interviews, books, death-bed confessions, and more, and with the internet, they are all at the palm of your hands. The only proof the government has is their "good word", and their "expert [paid] opinions", but they do not have the remains of the crashed "weather balloon" available for analysis by an outside source, and all other "official" documentation is as of yet unclassified.

THE AREA 51 CONSPIRACY

After the crash at Roswell, large trucks were seen to come into the area and to be removing objects and debris from the site. The objects are them rumored to have been taken to a topsecret military installation known to most as "Area 51" in Nevada.

Area 51 has remained (until most recently) one of the governments biggest secrets. They denied its complete existence for many years, and even know, will tell you that it doesn't really exist. However, driving along the dark Nevada highway, now dubbed the "Extraterrestrial Highway", makes you perhaps think otherwise.

Eventu- for further study. ally, it became public knowledge that this top-secret installation was being used as a test facility for many prototype aircraft, including bombers and stealth vehicles.

Getting out and taking a short walk, you will find the sign that prohibits entrance to this "nonexistent" location, as shown in the photo here. Photography is also prohibited, and violators are arrested, detained, questioned, and eventually released.

However, thanks to the invention of technologies such as GPS and cartography satellites, what was soon a well guarded secret could now be searchable and viewable from the sky via Google Maps.

Over the years there have been multiple documentaries, books, magazine exposes, and more about Area 51 and the crash at Roswell. We can pretty much say that after the object crash landed at Roswell, the military gathered up the debris and the

WHAT HAPPENED TO THE DEBRIS AND **BODIES ONCE IT REACHED AREA 51?**


Nobody truly knows what ever became of the crashed object or the occupants. Most people speculate that they are still there, hidden away in some secret, underground research facility operated with black budget money.

Over the years, witnesses, including those who have worked at Area 51, have claimed that they have seen the debris, as well as other "flying saucers" and objects, at the installation. Some also claim to have seen the bodies of the EBEs they found dead on arrival at the crash scene. Some people may remember the famous "alien autopsy" video that circulated a while back, featuring alleged scenes from the actual autopsy of one of the bodies recovered from the wreckage, as shown below.

> Q: I hear things in my house at night. I think sometimes that someone is in here with me, but I live alone. I'm not sure if I want an investigator coming to my house yet. What can I do? -Mary Adams, WI.

> A: Well, Mary, if you don't want to have an investigation team come thumping through your house, that is completely understandable. There are a few measures you can take to help you in your current situation.

> First, I would start keeping a journal. Whenever something strange or bizarre happens, write it down. Write down what happened, how it made you feel, and anything else you think might be pertinent ... CONTINUED

... This will help you see if there is a pattern to the events. If there is a pattern, it will enable you to see if there are potentially other causes of the phenomenon. For example, you hear loud creaks four or five nights out of the week, and they all occur at eight at night. Once you know this is a pattern, you can start to look for explanations. Perhaps a neighbor coming home from work, and the vibrations from his vehicle cause your house to creak.

This information will also help you to conduct some background research on your home. Did anyone die there previously, or have there been previous reports of phenomenon? If you can determine that your home is indeed haunted, you may want to consult with a paranormal research team or a medium to find ways to deal with the phenomenon. This could be anything from spreading tar water or casting a circle of salt to saying prayers and asking the spirit to leave. No two cases are exactly alike, and resolution of each case is usually different. Sometimes, you can't get rid of it, and you have to wait it out or move. It will depend on what happens in the case in the long run. I can't really tell you what would work best without knowing more specific details about what is happening.

Keep in touch and keep me up to date if you wouldn't mind. I'm always here to help if you have any questions or concerns. I can also refer you to reputable groups that will ensure confidential investigations into your encounters at your request. In any event, best of luck and bright blessings! -Bob-

Q: I think my teacher is a vampire. You know, one of those energy kinds that drains your body of all of its aura or whatever? Everyone in my class always gets really tired when we are around him, even some other teachers say he is weird. What can I do to protect me and my classmates from his attacks? - "Elvira", OH.

A: Well, Elvira, I'm going to start by saying not to stake him through the heart! ;-) Energy Vampires, sometimes called "Psychic Vampires", are an interesting phenomenon. Some PV's know they are vampires and willingly drain the energy of others, while some have no idea they are a psychic vampire (PV) and have no control over their "drinking".

I would normally recommend practicing putting up your personal "energy shield" to help protect you, but because your shield is made up of your own personal energy, it might actually make it easier for the vampire-in-question to feed directly from you.

You could try talking to the teacher, subtly, or outright, and determine if they know they are a vampire. If they do, and they insist on "eating" from you, then you should take more drastic steps to protect you and your classmates. If they don't know, but realize it, they may be able to stop themselves without having to pursue it further.

If you feel you still need protection, you and your classmates can always find protective amulets, charms, and the like from your local magic/occult shop. Mythology says that silver amulets work best against vampires of any sort, including etheric revenants ("ghost" vampires), as it causes them harm. There are also protective stones and other gems that can be worn, depending on your preference for materials. THE DEMONBABY OF HUEE HOUSE

Stories of a ghostly face in the windows of the infamous Hull House in Chicago have filled local lore and legend seemingly forever. Stories of the ghost of a demon baby born inside the Hull House

have haunted our history since I can remember, and it's one of my favorite Chicago Haunts stories...

HISTORY OF HULL HOUSE

Hull House was built in Chicago, Illinois in the near west side of the city. It was founded in 1889 by Jane Addams, and eventually grew over the years to include multiple buildings.

It was a "community of university women" whose goal was to promote and provide educational and social opportunities for the "working class". The resident women held classes on a wide range of to baptize the child unsuccessfully, and ended up subjects, including literature, history, art, and more. They also provided free lectures and concerts, and

operated children and adult social clubs.

THE HAUNTING OF HULL HOUSE


Addams had made impressions that the attic of the property was haunted long before it became famous. It was believed that the wife of the original owner/builder of the home, Charles Hull, who died in 1860, was haunting the top floor of her old home. It was already included in many tours of Chi-

> cago's ghosts given even then. However, in 1913, the story became terrifyingly different.

> Legends say that a man claimed to rather want to have the Devil in his house than a picture of The Virgin Mary, and his wife then gave birth to a child with scaly skin, a tail, and demonic pointed ears. A child of Satan himself. The father wanted nothing to

do with the child, and the mother allegedly took the baby to Jane Addams herself at Hull House.

It was rumored that Jane Addams attempted locking it in the attic. Although she denied these facts, she found the story ... CONTINUED

... fascinating and used it as a centerpiece of a book she wrote in later years.

Legend has it that Addams raised the child in Exhibits/janeaddams/photoshullhouse/ the attic until it's early death at a young age from it's Nursery1.jpg condition. It is rumored that if you look up to the second floor window, you will see the face of The Devil (or the demonic baby) looking back at you.

Personally, I can't wait to visit and look in the window, and tour the building myself.

WHAT IS THERE TODAY...

Over the years, the mansion and other attached buildings were renovated, remodeled, or otherwise altered to meet the changing needs and demands of the association, but the original building survives today, and is recognized as a Chicago Historical Landmark.

The Hull House Association ended it's operations in early 2012, but the mansion remains open to the public as a museum to this day. They operate by donation (suggested \$5, but they won't turn you away if you can't donate, either), and are open Tuesdays through Fridays from 10a-4pm and Sundays from 12p-4p. 

HISTORY OF BORLEY RECTORY

Borley Rectory was built was Rev. Henry Bull in 1862 after many townspeople insisted that the land was either "haunted" or "cursed". Local legends say that a Monastery once existed on the site in the thirteenth century.

The Borley Haunting would be Price's most infamous case, and would propel him into the spotlight and pave way for future paranormal research.

THE PRICE PHENOMENON

Shortly after a newspaper circulated a story about the phantom nun, Harry Price was contacted reports of phantom footsteps, strange lights, and white, a phantom coach, Henry Bull and the nun.

During his initial investigations into the case, Price attributed most of the poltergeist-like activity non, and that she was most likely unknowingly causing the occurrences through spontaneous telekinesis.

The Foysters moved out of Borley Rectory in 1935, and Harry Price decided to rent the rectory for a year so that he could conduct an "around-theclock" year long investigation of the location. He placed an ad for willing participants and investigators in the local newspapers.

Price hand-selected forty participants, and printed the first-ever "how-to" booklet on ghost hunting that detailed how they should pursue their investigations and how to operate the equipment they would be using during their investigations.

Over the course of the year, investigators would conduct wild experiments to try and debunk or cause phenomenon to occur. Others kept accurate and detailed journals about their experiences, which contained many strange and bizarre accounts

Harry Price and his investigators also began pioneering experiments in spirit communication. They began using a spirit board and planchett (the Ouija) to form words and communicate with the other side. Allegedly, the group made contact with a spirit named "Maria".

Price and his investigators would have many to investigate the property. He was intrigued by the sessions over the course of several months with "Maria". During these sessions, they learned that the alleged apparitions of a headless man, a girl in Maria was a young woman who was strangled to death by her husband and then buried her remains in the cellar.

This seemed to fit reports of the spirits that as having been caused by Mrs. Foyster herself, who had been previously encountered on the location. was acting as an unknown agent for the phenome- Price was pleased, and they continued to contact non. He pointed to the fact that Mrs. Foyster "Marie". However, a short time later, "Marie" made seemed to be the focal point of all the phenome- a prediction that changed the fate of Borley forever.

A TRAGIC PREDICTION

During one of the many "spirit board" sessions Price and his investigators conducted with "Marie", the intelligent entity they made contact with, she indicated to them that danger lay ahead.

"Marie" informed Price and his team that the Rectory would be burned and destroyed in a fire, and that after the fire, evidence of her murder would finally be found.

Well, time passed and the rectory did not burn down. A few months later, Price's lease was up on the property, and the year-round investigation concluded.

A short time later, the rectory came up for sale, and new owners purchased the home. When they were moving in, one of the new owners accidentally kicked over an oil lamp, causing fire to spread quickly throughout... CONTINUED

FAMOUS MIDWEST UFO SIGHTINGS

Although I can't find any cases that had national media coverage in the Midwest, I did find information on a case where the UFOs seemed to be studying the entire Midwest... and it happened in the 1800s!

According to Burlingtonnews.net, author Mary Sutherland brings to attention a strong of rewa, Minnesota, Nebraska, Wisconsin and Illinois.

The first sighting occurred on the night of April the 5th in Omaha. More than a hundred people witnessed the cigar-shaped object with a shiny, object in the sky.

A few nights later, in Iowa, several other people reported seeing the same/similar craft in Sioux City, Cedar Rapids, and Burlington.

Again, just a few nights later, in Chicago and in Mount Carroll, Illinois, multiple witnesses again witnessed the same object and they all had the same matching descriptions as before: an object with "rotating red and green lights". It was also seen in Quincy, Illinois. Later that night, it was reported in Wausau and Milwaukee, Wisconsin.

The following day, it was seen in Minneapolis, Minnesota. The next day, more reports came in from Wisconsin, and then a few days later from Indiana. A few days later, a similar object was seen

UFO'S IN CHICAGO IN 2006

At approximately 4pm on November 7th, ports that happened in 1897. THE UFO CAPITAL OF WISCONSIN

Chicago claims to be the UFO capital of the Midwest, quoting it's large number of well-documented mass sightings. However, a small town in Wisconsin says that it is the UFO Capital of it's own state.

In the 1970s, a police officer in Elmwood, Wisconsin had multiple repeat sightings of the same

object near his home. It was widely reported that he had witnessed a bright, orange glow. Thinking it was a fire, he went to investigate, only to discover that the glow was a UFO hovering 100 feet some off of the ground.

He radioed the sheriff's department and told them what he saw, but as

soon as he did, it shot up and disappeared. The officer claims that a beam of light shot down from the craft and struck him just before it disappeared, which killed the battery in his car and left Wheeler unconscious.

Wheeler was not the only one to see UFOs in Elmwood, Wisconsin over the years. It had been a relatively commonplace local phenomenon that was talked about amongst the townsfolk for years.

With the national media coverage, and the

widespread sightings of UFOs throughout the town and surrounding areas, the town declared itself the "UFO Capital of Wisconsin". They even host their own "UFO Days" the last full weekend of every July, according to their Facebook Page (https://www.facebook.com/UFO-Days-Elmwood-WI-Last-full-weekend-every-July-315363775176519/).


