fathers of modern-day ghost-hunting, stepped in. The Borley Haunting would be Price's most infamous case, and would propel him into the spotlight and pave way for future paranormal research.

THE PRICE PHENOMENON

Shortly after a newspaper circulated a story about the phantom nun, Harry Price was contacted to investigate the property. He was intrigued by the sessions over the course of several months with reports of phantom footsteps, strange lights, and the alleged apparitions of a headless man, a girl in Maria was a young woman who was strangled to white, a phantom coach, Henry Bull and the nun.

During his initial investigations into the case, Price attributed most of the poltergeist-like activity as having been caused by Mrs. Foyster herself, who had been previously encountered on the location. was acting as an unknown agent for the phenome- Price was pleased, and they continued to contact non. He pointed to the fact that Mrs. Foyster "Marie". However, a short time later, "Marie" made seemed to be the focal point of all the phenome- a prediction that changed the fate of Borley forever. non, and that she was most likely unknowingly causing the occurrences through spontaneous telekinesis.

The Foysters moved out of Borley Rectory in 1935, and Harry Price decided to rent the rectory for a year so that he could conduct an "around-theclock" year long investigation of the location. He placed an ad for willing participants and investigators in the local newspapers.

Price hand-selected forty participants, and printed the first-ever "how-to" booklet on ghost hunting that detailed how they should pursue their investigations and how to operate the equipment they would be using during their investigations.

Over the course of the year, investigators would conduct wild experiments to try and debunk or cause phenomenon to occur. Others kept accurate and detailed journals about their experiences, which contained many strange and bizarre accounts

Harry Price and his investigators also began pioneering experiments in spirit communication. They began using a spirit board and planchett (the Ouija) to form words and communicate with the other side. Allegedly, the group made contact with a spirit named "Maria".

Price and his investigators would have many "Maria". During these sessions, they learned that death by her husband and then buried her remains in the cellar.

This seemed to fit reports of the spirits that

A TRAGIC PREDICTION

During one of the many "spirit board" sessions Price and his investigators conducted with "Marie", the intelligent entity they made contact with, she indicated to them that danger lay ahead.

"Marie" informed Price and his team that the Rectory would be burned and destroyed in a fire, and that after the fire, evidence of her murder would finally be found.

Well, time passed and the rectory did not burn down. A few months later, Price's lease was up on the property, and the year-round investigation concluded.

A short time later, the rectory came up for sale, and new owners purchased the home. When they were moving in, one of the new owners accidentally kicked over an oil lamp, causing fire to spread quickly throughout... CONTINUED

It all started in August 1977, when a single mother named Margaret Hodgson rented a small home on Green Street in Enfield, England for herself and her four children. Her children consisted of two girls, Peggy and Janet, the oldest of the children, and two boys, Johnny and Billy.

It started with a shaking bed, and quickly escalated into strange noises, raps, and other instances of poltergeist-like phenomenon. Peg was terrified for herself and her four children, and made a plea for help. She called the police.

An officer dispatched to the residence reported witnessing a chair moving of it's own accord. The next day, lego's and marbles seemed to appear out of no where and bounce off walls through out the house.

Eventually, the Society for Psychical Research sent investigators Guy London Playfair and Maurice Grosse to pursue the case. Grosse and Playfair lived with the Hodgson's for a period of time to observe and record the phenomenon.

In the course of their investigation, reports of knocking noises, flying objects such as toys and furniture (and even a brick once seemingly targeting the mother) were all witnessed by multiple witnesses. Large furniture such as sofas and beds would move and seem to float of their own volition. The sound of "dogs barking" in a "dogless" room could be heard.

It was also reported that Janet had violent trances where she spoke in a strange, guttural voice for extended periods of... CONTINUED

... time, which would normally cause irreparable damage to the throat and tissues. Once, an iron fireplace was pulled straight out from the wood framing in the wall.

Even the infamous Ed Warren said he witnessed Janet, who seemed to be the target of nearly all of the occurrences, floating above her bed while she slept, and said that it appeared to be a type of demonic possession to him.

WAS IT ALL A HOAX?

Some investigators argue that Playfair and Grosse exaggerated many of the claims they made in the case about phenomenon and activity that they encountered.

Janet and her sister admitted to pranking some of the activity. Playfair himself, while maintaining that the activity was genuine, indicated in his own book about the case, *This House is Haunted: The True Story of a Poltergeist* (1980), that he doubted whether the children were telling the truth at times, and even witnessed Janet bending spoons with her hand, moving and hiding objects, and rapping on the floor with a broom handle.

Although the girls admitted to hoaxing some of the activity, they also claimed that they didn't fake all of it. Playfair and Grosse both agreed with this, and argue that there was just too much evidence pointing towards genuine paranormal activity for the two girls to be the cause.

THE EVIDENCE

The reasons that some argue that the phenomenon are genuine include that Janet and her sister were not the only two to experience phenomenon. Their brother Jimmy also reported that his bed was shaking on the very first night, and activity did continue in the household (although to a much smaller degree) when Janet wasn't present. One of the best known photographs comes from this case. It has been critiqued and examined over the years. Some researchers say that the photo shows "genuine poltergeist activity", while others insist that it confirms that Janet was hoaxing nearly all of the activity.

Paranormal Researcher Joe Nickell drew the following "forensics" copy of the image, and illustrated why many believe that Janet was faking the incidents where she would be propelled across the room. He and others use the photo to demonstrate that she in fact, jumped and propelled herself from her bed, as illustrated in the image below.

Still, others insist that even if this photo demonstrates that only this particular phenomenon was hoaxed, it still doesn't explain how furniture and other objects would move of their own accord, seemingly appear out of thin air and be hurled across the room, or how a small child could rig large pieces of furniture ... CONTINUED

on it's side.

Others point to the sheer number of witnesses that reported experiencing some type of phenomenon, including the police officer that first visited the house when Ms. Hodgson called them when the activity first began to occur.

OTHER THEORIES

However, some researchers also point out that Janet may have been the cause of the poltergeist herself. It is widely-accepted that some poltergeist activity is the result of a human agent.

Over the years, researchers have determined that a wide-range of cases of poltergeist activity are caused through telekinesis, the ability to move objects with one's mind. Because most cases of poltergeist activity occur in instances involving teenagers (especially those beginning puberty, which Janet was), it is theorized that when a teenager begins to experience these changes in the body, the hormones and chemical changes can cause them to temporarily access a part of the brain that causes spontaneous telekinetic activity.

Usually, when the subject, or focal point, of the phenomenon, becomes upset or angered, there has been a noted increase in the level of poltergeist type phenomenon. It has also been reported that the activity subsides after the agent confronts what-



... to move across great distances or be turned over ever is causing them to have such strong feelings, or when the child gets through the largest transition period.

> Pubescent women are the most likely to experience poltergeist phenomenon, and many times it ceases or becomes less active after the arrival of the victim's first menses. This was also true in the case of the Enfield Poltergeist.

After Janet had her first period, much of the activity in the home diminished, and by 1979, all of the activity in the home had stopped.

CONCLUSIONS

Can we say for certain that the Enfield haunting was faked in it's entirety by Janet and her sister? No. There are many instances where Janet and her sister were not present, and activity was still reported. Can we say for certain that the Enfield case is a legitimate poltergeist phenomenon? Unfortunately, since Janet and her sister did confess to hoaxing at least a portion of the events, no, we cannot say for sure that it is a genuine phenomenon.

This case has left some researchers baffled. Some believe that Janet was the "agent" for some of the poltergeist phenomenon, and even Janet herself admitted that she only faked about "two percent" of what was encountered during the two years of recorded occurrences.

No one can say for 100% certainty, however, either point-of-view. It depends on who you believe? The skeptics who say it was all faked... or the believers and witnesses who say that it is genuine. It's up to you to decide...

THE CLOSE ENCOUNTER **CLASSIFICATION SYSTEM**

The original Encounter Classification System was developed by Dr. J. Allen Hynek, one of the world's most infamous UFO Researchers. His syssearchers and investigators to more clearly separate adds "medical experimentation or examination" to certain aspects of some encounters from others.

Currently, the generally accepted classification system has six parts, known as CE's. The first is a general sighting of a UFO in the sky or from a distance. A CE-2 would involve the UFO leaving some type of trace or physical evidence behind such as a burn, crop circle, or other chemical/physical evidence. This type of encounter is rare, and only a handful of sightings ever produce physical evidence such as a burn or spot.

THE BETTY & BARNEY HILL INCIDENT

There have been a wide range of credible sightings over the years, many with expert, trained witnesses such as police officers and armed forces pilots. Many of them have been documented and have had books written about them or movies made based on the accounts.

One of the most famous cases and most investigated cases of all time is the Betty & Barney Hill Incident. In September 1961, in the state of New Hampshire, the couple were driving home after taking a vacation in Canada.

It was just past ten in the evening, when the couple saw what they described as a 'bright star' that was moving 'erratically' (CE-1). They began to observe it, and watched as it appeared to move in and out from behind trees in the distance. After a short time, they decided to pull over and attempt to view the object using a pair of binoculars.

They described the object as being "flat with windows and multi-colored lights". They also indicated that they could see occupants inside the craft (now the case has become a CE-3). They became frightened, and ran back to the car and sped off. That's when things got really weird.

The next thing they knew, they had driven thirty miles and couldn't remember the last two hours of their lives. They didn't remember anything strange, but couldn't see the craft anymore. It was only after Betty started having disturbing dreams involving the couple being abducted that they started talking about their experience.

It was eventually uncovered through hypnosis that the couple remembered being abducted, taken aboard an alien ship, talking with the EBEs, and

having medical experimentations completed on them. They provided explicit details, and even recalled being told that they wouldn't remember the incidents.

One of the strangest pieces of evidence has popped up more recently, as our technology has advanced. The Hills provided a drawing of a star system called "Zeta Reticuli", which only after we started gazing into the stars in recent decades, have we discovered that the drawing provided nearly exactly matches what we can see through our highpowered telescopes today.

How did the Hills provide a map of a star system not yet viewable from earth using current technology in the 1960s? Did they actually visit another planetary system as they describe? The evidence seems to point to a big fat 'yes'.

Overall, more and more people have a UFO Sighting or EBE Encounter. Today's age has made it easier for us to share our sightings online, but has also made it easier to fake videos and images, making our job as investigators more difficult to pick out true UFOs from hoaxes.

UFOs aren't limited to discs and grays aren't the only aliens that are out there. Evidence is continually mounting which points towards the likely probability that life outside of earth exists, and an increasing number of people believe that such life may be visiting Earth.

However, with all of our knowledge and experience, and all of the data collected, we still can't know for sure what their intentions are. But, hopefully, with enough collected evidence from everyone's encounters, we will be able to get a better picture of the other types of beings and life that inhabit our galaxy. Perhaps one day, they will just come knock on our door. The question is, however, are we prepared to answer it?



Conducting Background Research

Millions of records are stored and archived in places other than some online storage facility, and are only searchable through manual means. Yes, I said manual. This means you will have to leave the house, which I know for some of us is quite a chore in itself! But don't worry, we're going to give you some tips to make it easier for you!

ONLINE SEARCHES

Although you aren't likely to find all the information available about a case online, you can al-



Conducting background research for the ways start there. It is important to know, however, case you are investigating can be a very daunting how to tell a bad source of information from a good task. Sure, you can conduct a few internet searches, source of information. This can be tricky, and by all but chances are most of the information you will means should deserve an article all to itself, but here

- 1. Check the URL. Is it a .com, .gov, .org or .edu website? Is it the actual official website of the source it claims to be?
- Are there a lot of ads and "click traps" on the website? Although sometimes you can find some good information on these sites, most of them are only to "trap" you into clicking ads. Avoid these whenever possible.
- 3. Check your sources source! That's right, see where they got their information from. Is it a reputable source? Or are they just passing along misinformation from an unreliable source?

These are just a few of the things you can look for in your web searches to make sure you are getting "good" sources for your information. You can also use Boolean Operators, such as the words "AND" or "NOT" in your search engine, which will help it narrow down its search parameters and eliminate a lot of excess "junk" that will come up.

LOCAL SOURCES

Once you have scoured the internet, it's time to hit the stacks. Go to your local library, Historical Society, or municipality records office. (You may have to pay for records through the municipality, whereas you may only have to pay for copies through the libraries or historical societies).

chives that you can manually search through. Many searches, which can sometimes be hard to do with also have large volumes of microfiche, which is a centuries of data to sort through. tape which contains photos of publications like newspapers and other periodicals. You can search through them for articles relating to the background of the location and case(s).

Many also have many paper books filled with copies of land deeds, cemetery maps, old zoning maps, construction blueprints, and the like, just waiting to be explored. My personal favorite is the Genealogy room, which studies families and family histories. You can also do research to see if you can find any living descendants of previous occupants of locations using these techniques, which can help you build a case/spirit profile if they have encountered similar events previously.

Also, local authors often publish books about legends, lore, and the paranormal that are often out-of-print or otherwise hard-to-find and may only available at your local library. Sometimes, members of the Historical Societies may also have heard a tale or two about your case, and can point you in the right direction (as long as you speak with discretion and respect to your client's confidentiality wishes, of course!).

When you are researching a property or location, it is important to get as "big" of a picture as possible. This means you may have to go back through hundreds of years' worth of records. Using keyword searches and browsing through card indexes can help you narrow your search parameters.

It is also important to "leave no stone un- now fit the spectrum of the phenomenon. turned" as they say, meaning you will want to ensure that you have researched every possible angle you can think of about your case/location before incorporating your findings into your spirit profile.

INCORPORATING YOUR FINDINGS

After you've completed hours upon hours of research, you are ready to add to your spirit profile. What did your research reveal? Are there previous reports of activity on the location? Do they match what is being reported? Does the location have a strange or violent history? Were there any known deaths or tragedies on the property? Who built the property? If it is a commercial building, what other businesses have operated in this space? Who owned them and what are their histories? The list of questions you will find answers to in your research goes on forever and ever.

Incorporate what is most important and pertinent to your case. If there was a fire a hundred years ago on the property and the current occupant keeps smelling smoke, chances are they could be related phenomenon (further research/investigation would be required to confirm this hypothesis). However, finding out someone is behind on their mortgage and could be looking for a quick moneymaking scheme can be helpful in determining the direction your investigation will take as well.

Figure out what fits and does not fit "the puzzle", and include it in your spirit profile. Keep all your case-related research for later review. You may find something useful later in your investigation that you may have thought was useless earlier, or something that didn't apply previously that may

In the end, your research can make or break your investigation. Poorly done or a lack of research can lead to inaccurate results and finding(s). Good research, however, gets good results.

PRIMARY BELIEFS OF SPIRITUALISM

There are three primary beliefs of Spiritualism, in addition to the belief that spirits are capable of contacting humans, but that the spirits are also more advanced than we are, and that they also have cal doctrine/texts to follow, which allowed the beuseful knowledge about moral and ethical issues and lief system to flourish for a half a century. GROWTH OF THE RELIGION

It did not die out, however, and is still practiced today in much of the United States, Canada, and the United Kingdom. I myself have several Spiritualist beliefs, partly due to my pagan background.

HOW DOES A **SPIRITUALIST COMMUNICATE** WITH THE SPIRIT WORLD?

Most often, a medium, or person who is sensitive to the spirit energy, or who can talk to the spirits, is used to facilitate such communication. Not everyone can openly communicate with spirits, as people's levels of perception differ. I myself can only "feel" presences, and may get emotions or feelings, but I do not "talk" with any spirits such as this.

At times, a substance known as ectoplasm was produced by certain mediums (most of which later turned out to be fraudulent). It was said to be a natural by-product of the human/spirit interaction. [Most times, however. the medium swallowed the cloth before the séance, and threw it up during/after to make it seem like it was expelled by an unknown entity or caused by the interaction, which is was aided in discrediting the field].

... were caught faking previously reported "real phenomenon" such as glowing lights, tapping noises, voices/laughter, and even ghost photos.

THE FOX SISTERS FAUX MEDIUMSHIP

The Fox Sisters, Margaret and Kate, of New York, were one of the most noted, publicized, and rebuked Spiritualist groups of their time. In the late 1840s, they sensationalized Spiritualism by conducting a series of séances for on-lookers where they "made contact with spirits" who responded to their questions through series of tapping and rapping sounds which seemed to come from nowhere.

However, in 1888, they admitted that the contact they made with the spirit was false, and that they faked the whole thing, only to recant their confession shortly after. This incident, and other incidents like it, were the primary causes of the downfall of Spiritualism. People just couldn't get past the amount of fakes and hoaxes there were, and how easy it was to fake a séance.

In the years that first followed their sensationalism, mediumship was a profitable business. It's easy to see why one would want to try to "cash in" on it's success through hoaxing phenomenon. Although, thankfully, many times the hoaxers and fakes got taken to court, it caused a bad name to be spread around for true mediums and true spiritualists.

The final contributing factor to the fall of Spiritualism was the lack of organization of the religion. There was no official doctrine to follow, no official rule book, and no true way to test and confirm mediumship, making it easy enough for anyone to claim to be a spiritualist who had a table and chairs and a spirit board handy.

SPIRITUALISM SURVIVES DEATH

Although it became pretty much non-

existent after the 1920s, some Spiritualism centers continued to operate and teach the teachings of the "church". Later, an actual "Spiritualist Church" would be founded (such as the William T. Stead Center, founded in the 1920s in Chicago, Illinois), which would help to carry on the ideas into the next century.

Later, in the 70s, 80s and later as paranormal research became more popular of a subject, Spiritualism and it's ideas were brought up and studied. Mediumship became a more commonly accepted gift, and some of the basic beliefs of Spiritualism were again put into common practice: communicating with spirits. Attempting to record EVPs (electronic voice phenomenon) is a standard task in every ghost hunters investigation. It stands by the belief that the spirits are able to communicate with the human world, which is the founding tenement of the Spiritualism belief system.

Many churches continue to operate today, although spread far and few between. Ghost hunting groups also regularly call on mediums and psychics to aide them in their paranormal investigations today. I myself have several friends who are gifted mediums or possess other psychic abilities. It's beginning to be a new resurgence as more and more people begin to question and study the afterlife, spirits, and the unexplained. And I personally can't wait to see what we find out...
