#### THE EASTLAND DISASTER Chicago, Illinois

The Steamship Eastland capsized on the Chicago River between the Clark and LaSalle Street bridges on July 24, 1915. It had just left dock and was headed to Indiana, and had about 3,200 passengers on board.

> The developer, however, to save on time and costs, made a fateful decision when it came to the Black Hope Cemetery that laid smack in the middle of the planned development. They moved the headstones and markers that they could find, but didn't move any of the bodies. To this day, they attest that they "didn't know" about the cemetery being locat-

... development, and that they simply "built on top of" what they thought was "open land".

The Williams' tried to dig up one of the graves on the property, but the sudden death of their daughter, which they believed was caused by supernatural forces, ended their attempt to prove the cemetery existed.

The Haney's, the Williams', and other neighbors tried to sue the developer and get their money back for having not been told that the home resided visio on a cemetery, but it was to no avail. The movie caus "Poltergeist" had recently become a box office sensation, and due to the similarity of the stories, many yard thought that the residents were simply trying to cash law. in on a "good story".

In fact, the movie was even presented as "evidence" during the Williams' attempt to sue the developers in court. However, the Haney's and Williams' research proved that the cemetery did indeed exist, and that many of the bodies were buried by a local man named Jasper Norton. Mr. Norton was the person who informed the Haney's that the homes in the subdivision were built atop the old cemetery. He also confirmed that at least sixty people were buried in pauper's graves in Black Hope Cemetery, many without a permanent marker. Many

of the persons buried at Black Hope were freed slaves, and the last burial in the cemetery took place around 1939.

Eventually, the Haney's won their suit and were awarded over \$100,000 for mental anguish, but a reversal caused the verdict to be dismissed and the Haney's ended up paying over \$50,000 in court costs.

Many of the residents of the Newport Subdivision sold their homes, many incurred a loss because they had the responsibility to tell potential buyers that the home was built on top of a graveyard and that it may be haunted according to the law.

However, in the years since many of the original owners have moved, not one of the residents who purchased these homes "second hand" have experienced (or reportedly experienced) any type of supernatural or paranormal phenomenon.

Ben & Jean Williams published a book about their experiences called "The Black Hope Horror", and the story was featured in an episode of "Unsolved Mysteries". The book later inspired a film starring Patty Duke entitled "Grave Secrets: The Legacy of Hilltop Drive".

... It was also reported that Betsy couldn't spend any time with Joshua anywhere near the property, else the entity would taunt them. Eventually, Betsy gave into the demands of the spirit and broke off her engagement to Joshua.

#### THE ENTITY TURNS IT'S ATTENTION

After forsaking her marriage to Joshua, incidents seemed to decrease for the family. John Bell, however, continued to be a target. The voice of the spirit relentlessly vowed to kill Mr. Bell. As the years continued to pass, and Mr. Bell fell into worsened health, the entity continued to taunt and attack Mr. John Bell, laughing at him. One time it was even reported to have pulled his shoes out from under him, causing him to fall.

In December of 1820, John Bell died shortly after falling into a coma. Shortly after his death, the family found a suspicious vial of unidentified liquid in the cupboard. When given to an animal, the animal died on the spot. The entity was then reported to have given John Bell "a big dose" of the poison on the night of his death. In disgust, one of the family members threw the vial, which exploded in flames and disappeared.

#### THE ENTITY RETURNS

At John Bell's funeral, attendees claimed to hear the voice of a woman signing hymns and laughing loudly, even though no earthly person present was singing or laughing. It was also said that the ghost laughed and sang all the way until the last person left Mr. Bell's graveside.

In Spring of 1821, the entity visited Mrs. Bell and told her it would return seven years later. It did, and the activity centered around John Bell, Jr., with whom the entity talked of deep, spiritual things. The entity eventually said good-bye to the Bells, promising to return to a direct descendent after 107 years. It was never seen again.

## Rock Paranormal Recruiting New Team Members in Chicago Area...

Since I have moved to Chicago, and taken the headquarters for the team's operations with me, I have to find a few good people to join me on my quest for knowledge as a paranormal researcher.

Erin Rose, Russell and Melissa are all staying on board, but with the distance between us, will be taking a less active role in the organization. They will still partake in investigations and team activities whenever possible. That leaves a large gap in the team.

I'm only looking for a few serious and dedicated individuals who would like to learn about, discuss, investigate, and write about the paranormal. 4. It's not always as you see on TV, with cameras and instant fame. It's about hard work, dedication, and a commitment to learn about, try to understand, and share your experiences of the paranormal with others, and help others who are experiencing the paranormal and need it.

This could be one person, it could be two or three more people. It will really depends on who is sincere enough in their interest to complete the application and training processes, and has a commitment to working as a team.

#### THE BASIC REQUIREMENTS

There are a few basic requirements for any member of Rock Paranormal:

- You must be able to stand, walk, sit, or hike for extended periods of time. We investigate different places, and partake in different activities at various sites which will have you doing all varieties of physical activity.
- 2. You must have an interest in studying and re-

searching the paranormal. This is more than just a passing interest in ghost hunting, or enjoying the television shows (although that doesn't hurt, either). You must want to spend hours researching at the library, interviewing witnesses, sitting in strange places, sitting reviewing hours of videos, photos, and audio recordings, and be able to write about your experiences during the investigation.

- 3. A willingness to follow all standards, policies, and procedures as required by Rock Paranormal and it's founder, Robert Markin.
- An ability to commit time to the group for meetings, investigations, research and other related tasks.
- 5. You must complete the Rock Paranormal Investigator Orientation and Training Program in order to actively participate in field investigations.

#### WHAT YOU WILL BE DOING

From the television shows, many people assume you simply stroll up to a haunted location and start investigating. That's not always the case, and even when you do investigate, there is usually a lot more than what they show you on the television.

- You will be operating small electronic equipment, such as digital cameras/camcorders, audio recorders, and sensitive measuring devices such as EMF and/or MEL meters. Training will be provided.
- You will be interviewing witnesses using prescribed scripts and methodologies.
- You will be conducting background research into cases, which ... CONTINUED

- You will be writing reports based on the investigations, your encounters and experiences during case as requested by the Lead Investigator/Case Manager.
- You will be conducting EVP sessions, using Era questionnaire. • Ques, and participating in recreations/reenactments at the request of the Lead Investigator/Case Manager.

#### THE TRAINING PROGRAM

The Rock Paranormal Investigator Orientation and Training Course was designed by the team's Founder and Lead Investigator/Case Manager Robert Markin. It is broken up into several modules, each which has a lecture, required reading and investigative researcher for Rock Paranormal, visit questionnaire, discussion questions and/or applica- our website now: www.rockparanormal.net, or ble case studies.

Participants will study a broad selection of paranormal topics, including ghosts and hauntings, UFO Sightings & Encounters, Cryptids & Creatures, and famous cases. They will also learn of the history of Rock Paranormal, and learn about investigation practices and procedures, equipment handling, and more.

The course is designed to be taken at the stu-



## THE QUIJA BOARD, Continued...

#### YOUR PERSONAL SHIELD

First, you should always be concerned with your safety. Psychics usually go through a practice they call "Shielding", in which they use their personal energy to erect a shield or wall against energies, which creates a personal protected space around the individual. This is a good practice for everyone who will be partaking in the event.

You do this by meditating and envisioning your inner energy created a shield that moves out from and away from your body, creating a wall of armor that is impenetrable. Once you have erected your "shield", you can move to the next steps.

#### **CREATING A PROTECTED SPACE**

The next step you should undergo is creating a protected space. Many believe that casting a circle of salt will create a protective wall against negative or evil energies. Others insist that an imaginary wall, or an energy wall, such as created by Wiccans for their practices, is effective as well.

Personally, I use both methods. I use salt when I cast a circle for Wiccan work, and I would

probably use the same circle for protection during the séance. It is important to remember not to cross the barrier of the circle without cutting open a door and sealing it behind you every time you enter and exit the circle. Failure to do so can allow spirits to cross the doorway once the seal is "broken".

#### DO NOT PROVOKE THE SPIRIT

You are already potentially making any spirits you are trying to contact angry by disturbing them, you don't want to provoke them with harsh words or language. This will result in only a few different results: you will be ignored, you won't get full cooperation, or you'll anger the entity in question.

Also, do not ask it to touch you or invite it to take control of your body. It should be obvious why you should avoid these circumstances, as they will open doorways into your sacred space that will allow potentially negative entities into the space.

#### **REMEMBER TO CLOSE THE CIRCLE**

Thank the spirits for attending you at the seance and/or for communicating with you. Bid them goodbye and don't be afraid to tell them they

can't follow you home and that they have to go back where they came from. Also, remember to close/take down your circle in reverse of how you erected it.

If you follow these steps, you'll have some basic protections should you decide to utilize a Ouija Board or conduct a séance. Just remember, be careful, you really don't know who may be on the other end of the planchett! Good Luck in your endeavors!
