

Most people don't realize that there are several steps a serious investigator must take in order to gather enough information about the event and it's participants to get a "whole picture" of the encounter. It's much like being a detective, but it also requires some heavy book work and research.

STEPS OF AN INVESTIGATION

Every investigator does things his or her own way, but there are generally accepted steps to complete a paranormal investigation.

- 1. Interview the clients/witnesses
- Conduct Historical Research
- 3. Conduct walk-through with sensitive
- 4. Conduct additional investigation/vigil(s)
- Review Evidence
- Compile Profile/Report Findings
- 7. Follow-Up with Client/Witness

The first step is one of the most important. When you interview clients and witnesses, you need to provide them an environment where they feel comfortable and can easily open up and talk honest-

THE WALK-THROUGHS

After the initial interview, you should do one of two things. If your team works with a sensitive, the lead investigator, the sensitive, and a camera operator should take a walk through of the location first. This way, you can see what the sensitive feels, and if they can provide any additional information that might corroborate your research findings.

You should conduct your team investigation with your equipment, but limit equipment to what is necessary on each individual case. We recommend having no more than a small group of people on an investigation, we prefer a maximum of four, unless the location warrants additional investigators.

You should walk around the location, and conduct EVP recording sessions, take EMF readings, and take multiple photographs. It is best if you can record the investigation with a camcorder or other recording device to document any potential activity as it occurs, but it is not necessary. We suggest the following equipment for an investigation:

THE EQUIPMENT LIST

- 1. Notebooks and sketch pads
- 2. Pens and Pencils, erasers
- Cameras and batteries
- Flashlights (if at night)
- First Aide Kit
- Camcorder
- EMF/Mel Meter
- 8. EVP Audio Recorders (At least 2)

THE INVESTIGATION PROCESS

You should walk around the location and document (in your notebooks) any strange sensations, feelings, encounters, noises, and the like. Really, pretty much anything and everything that happens (you never know when that weird growl you heard was actually someone clearing their throat in another room!). You should also create a map of the location at the start of the investigation, and take base readings of the property, noting strange fluctuations on the map for investigative reference.

gation vigils, you should then do two things: review your evidence and compile your profile.

REVIEWING EVIDENCE

Reviewing the evidence is probably one of the most tedious tasks of a ghost-hunter. It takes hours of listening to most often white noise, or reliving the investigation word-for-word multiple times at different volumes and through various filters. It also involves extensive analysis of photographs using multiple analysis techniques, and watching hours of footage.

You should never review your evidence the as well as dust masks and a cell phone. A laptop can and it's best to review your evidence with a fresh set dence the next day or even the following day.

> You shouldn't jump to conclusions when you do find potential evidence. Bring it to your Lead Investigator's attention, and review it as a team. You may want to consider going back on an additional vigil to attempt to locate any possible natural or man-originated sources for the phenomenon, or attempt to gather additional evidence to confirm your theories.

You need to look for connections between all of the puzzle pieces, and see how everything "fits' together to make the phenomenon occur. Genuine haunting activity usually have some type of Spirit or entity with distinct attributes or personality, while psychic phenomenon usually have an agent, or person who is causing the phenomenon to occur. You need to use your findings to tell the difference, and make a determination as if to the either paranormal or natural nature of each case.

(NOTE: Sometimes, you'll come across people who are hoaxing phenomenon for whatever purpose, and it is best to just excuse yourselves and leave.)

THE FINAL STEPS

After you build your Spirit Profile, you'll have to reveal your findings to the client/witness. Rock Paranormal provides the client with a "Master Investigation Report", a CD with copies of photographs, audio files, and any associated reports/ reviews. It is also important to recommend a set of next steps to the client, and encourage continual contact.

Why recommend steps? Well, nine times out of ten, your clients will contact you because they not only want to know what is going on in their house, but how they can fix the problem. This resolution can come in many ways. Some people just want to know something is there, but others may want help to make it stop. These folks you'll have to work hard for to provide them with the outside resources Compile a "Master Investigation Report", or and contacts they will need to help them in their ena "Spirit Profile" as some call it. A COUNTRY HAUNTING

This place will give you the creeps just driving up there, however, you have to go through private property to get here, and I wouldn't recommend trespassing. There is a long, curving gravel road lined with trees. It leads up to an area surrounded by trees and a small woodsy area. There is a clearing ahead. To the right, you drive past a decrepit chicken coop, then you'll come to an opening in the road that leads to a big clearing. To the left of you is what remains of a home, to the left is what time we visited, the noose was cut down. The third remains of a barn. You've arrived.

We investigated this place many years ago, and try to make it back when we can. This place makes all of your hairs stand on end, and even though there is supposedly no man-made electrical lines or sources on the property, strange EMF spikes and odd cold-spots are detected all over this property. Cameras refuse to function, and EVP recorders only record static. But that's not even the strange part.

To story of this place, as local legends tell it, is that it was once owned by a wealthy man and he lived there with his family. They had a wealthy plantation, and he had many workers, who lived on site (you can still find the brick and concrete foundations of many small out buildings on the property, which match the description of the "help's" quarters.

There are variations on what happened next. Some say he had a drinking and gambling problem, and ended up having to sell off all of the farmland surrounding his plantation (and his help) to pay off debts. Others say that he just went crazy and started secluding himself in the house, and sold the land off to pay off his accruing debts from not working and being ill. Either way, the land surrounding his house


was sold off to other families, and his help left when they no longer had work.

One night, the man went crazy and burned his family (and himself) alive in their home. The foundation of the house does seem to corroborate this story, and the land stood vacant for years.

The first time we visited this location, the barn was still on the property. However, there was a noose hanging in the barn. It definitely creeped us all out, and we didn't stay very long. The second time, the barn was burned down.

We inquired into local historians and newspaper articles, but couldn't find anything to substantiate the fire or the noose. We did hear that someone had "heard" that a man was hung in the barn, and they cut him down after they killed him. The person then said that if the barn was burned down, it was probably "to hide the evidence". Although we cannot establish much of the historical facts of this location, all of the local "stories" we hear about the property apparently seem to correspond with events that appear to have happened at the location.

The location of this property has been obscured to prevent unauthorized trespassing.

HERBOLOGY STUDIES CONTINUED:

More Herbs & Their Practical & Magical Properties... By Robert J. Markin

As fall comes to a close, we are all beginning to wonder when the snow is going to start falling. And, once the snow starts falling, the noses start running and some of us end up with either a cold or the flu.

I don't know about many of you guys, but I prefer to try and put as much natural stuff in my 1 C. Dried Irish Moss body as possible rather than chemicals and drugs. (Although, sometimes there just isn't a better cure than some cough syrup from your local pharmacist!)

With that in mind, I've decided to dedicate 1 C. Rosemary leaves this issue's Herbology common to herbal cold & flu remedies. You probably have some of these things already in your house, and if not, you can pick up a small batch from your local grocer or herbalist relatively inexpensively.

HERBAL FEVER REMEDY

You will need:

1 oz. dried Elder flowers

1 oz. dried peppermint leaves

1/2 pint distilled water

Honey to sweeten (if desired)

Boil the water. Mix the herbs and place them in a quart-sized saucepan. Once the water is boiling, pour over the herb mixture. Cover, and allow to sit Add water to pan, add grated ginger to water. Boil and steep in a warm place for 10-15 minutes (do mixture together for 15 minutes. Remove from steeped, strain into another sauce pan, and serve can either strain the ginger out or leave it in, and warmed. Add honey to sweeten if desired.

Drink this tea a few times a day at the onset of fever to help your body cleanse and detoxify.

PEPPERMINT-ROSEMARY-ELDER TEA

This is another variation of the Herbal Fever remedy, but instead you will make a batch of dry tea for continued use.

You will need:

1 C. Dried Black Elder Flowers

1 C. Juniper Berries

1 C. Peppermint leaves

1 C. Plaintain

Mix all of the herbs in a large bowl. Then, store in an air-tight container for later use. When ready to make tea, steep 1 TBSP of the herbal mix in 1 C of boiling water for 15 minutes. Then, strain, reheat, and sweeten with honey. Drink this tea twice daily to help your body cleanse and detoxify.

GINGER TEA

Ginger is an antiviral, and this tea helps to break up mucus, congestion, and fight viral agents. This is also excellent if the stomach is affected.

You will need:

2 TBSP Grated Fresh Ginger

2 C Water

HERBOLOGY STUDIES CONTINUED:

Some other herbal tips that can help you stay healthy and happy during the cold and flu season include:

- 1. Make a warming tea with ground cinnamon, 6. cayenne, and ground ginger. Add small amounts to warm water to taste. (Helps you sweat it out!)
- 2. If you are having problems sleeping, try drinking cups of chamomile tea twice a day to help calm nerves and relax your body.
- 3. Use inhalations of chamomile, eucalyptus, or thyme. These can be made by boiling herbs in water, and using a towel over your head to inhale the hot "fumes" as they come off the pot. Put the rose petals and water in pan and bring to help to open nasal passages and bronchial tubes.
- 4. Horsetail (the herb, not the actual horse's tail!) inhalations (See above) reduce the swelling of Once cool, bottle in air-tight container. Take a the body's mucous membranes.
- 5. Elderberry extract has been found to reduce the

- severity of symptoms and duration of the flu. Using an extract that contains at least 5% flavonoids and take twice daily.
- Garlic also helps to detoxify the body. Taking garlic pills/supplements (500mg) or eating a garlic clove 3 times a day for up to five days will help your body rid itself of toxins and cleanse.

ROSE PETAL ANTI-DEPRESSION TEA


To fight off the winter blues, you will need:

20-30 rose petals

2 Cups Water

This will help loosen mucus, heal the throat, and boil. Boil for 15 minutes. Remove from heat, and allow mixture to steep while it cools completely (approximately 15-30 minutes).

Ghost Boxes & Ovulus Devices

There has been a varied amount of success with ghost boxes again in recent times. Many shows have been using them, and an increased amount of teams are using them on their investigations as well. However, there are two sides to every tale. Some investigators swear by these devices, while others swear them off.

The purpose of the ghost box is that it is rigged to scan through all the multitudes of AM and FM radio frequencies at a high speed. By doing this, the box produces a kind of "white noise" that is believed to be accessible by spirits for communicative purposes. This is where the dispute begins.

The ghost box does produce some interesting results for some teams, but you have to take into consideration the fact that you are scanning radio waves. These can have radio stations that are playing music, radio plays, talk news shows, and other stations that will be a part of your scanning range.

This can mean many strange, odd words, phrases and sounds might come through during an investigator's use of such a device, which could then be passed as "evidence", when it is really just a manmade occurrence that was misconstrued by the investigator.

Personally, we've had mixed success. Sometimes, it seems that the device is giving us answers to our questions, other times it seems just like we are scanning all of the radio stations and getting a lot of "noise".

The same goes for use of the Ovulus or other devices that ghosts are somehow able to manipulate to form words. Some investigators argue that "if these are spirits, some of them hundreds of years old, how do you expect them to know how to manipulate a piece of modern technology in order to

communicate?". It brings up a good question. Exactly how are the ghosts able to manipulate these technologies to communicate with us? I have to stop and think, if I were a ghost from the past, would I even have a clue on what an electronic machine is? And even if I do, how would I know what to do to make it work?

There are too many variables in my opinion to make either of these devices a very effective way to gather real attestable "evidence" of a haunting. You can't prove that the voices that came through the Ghost Box weren't from a stray radio broadcast, and you can't for certain say that a ghost 100% could manipulate the Ovulus device enough to make it work.

Although some teams swear by these devices, we at Rock Paranormal encourage you to use them with caution and only as an investigator's tool, but not as a source of definitive evidence. These devices can definitely assist in opening communication with the spirit realm, but don't take every hit you get as proof positive of the paranormal.

Channeling is where a medium goes into a trancelike state, and allows him/herself to act as a "conduit" for the spirits to communicate through.

It's been common in our heritage to consult with mediums, or to attempt our own communication with the spirits through various practices and rituals. Even the great composer Wolfgang Mozart was said to have "heard the music in his head, and then simply just wrote down what he heard", and many attribute this to a form of channeling (Buckland, 2004).



A: Anna, shadow people, or shadow walkers as some of us have termed them, are believed to be dark entities that walk this earth. Not all of them have malicious intentions, but some of them are rumored to be the cause of foreshadowing certain events or appear at the height of some paranormal activity.
